The next IAML conference will be held in Stockholm, Sweden, August 10-15, 1986. If you have always dreamed of a trip to Scandinavia I urge you to consider making it this summer, so that the IAML conference can be part of your itinerary. Almost all of us who have attended IAML conferences have gone at least partly (and sometimes entirely) at our own expense, and have attempted to combine our vacations with the meeting. The chance to visit an interesting place, and the professional stimulation of the meet-

ings with music librarians from around the world makes it well worth the effort and expense. Active participation of a large proportion of our membership is important for both CAML/ACBM and IAML.

CORRECTION

It was implied in the annual conference summary (v.14, no. 12) that RIAA curves are used to restore acoustic 78's, but this is not the case. RIAA Playback Equalization Curve is an international standard for the playback of modern phonograph records. This equalization has been built into every phono preamplifier since 1953, and to properly restore acoustic 78's one must bypass the RIAA equalization section of the phono preampusing an OWL restoration module. The OWL also allows you to properly equalize any electrical 78 recording.

PROPOSED AACR2 REVISION AFFECTING PSEUDONYMS

A proposal has been submitted to the Joint Steering Committee for Revision of AACR which, if accepted by the JSC, would significantly alter the rules for the handling of pseudonyms. The proposal is that rule 22.2C2 be abolished.

The proposed change affects those cases where a person uses more than one pseudonym (or a real name and one or more pseudonyms). The present rule requires the cataloguer to determine whether or not one of those names has been used predominantly; if so, that name is selected for all works by the person, regardless of the name used in each individual work. The proposed change would cause each work to be entered under the name appearing in that work.

There are strong arguments both in favour of making this change and for keeping the present rule. The Canadian Committee on Cataloguing feels strongly that input is required from the entire Canadian library community before it formulates its stand on this issue.

PROJET DE MODIFICATION DES RCAA2 CONCERNANT LES PSEUDONYMS

Le Joint Steering Committee for Revision of AACR a été saisi d'une proposition qui modifierait considérablement les règles applicable aux pseudonymes si elle était acceptée. Cette proposition vise à abolir la règle 22.2C2.

Le projet de modification touche les personnes utilisant plus d'un pseudonyme (ou leur nom véritable et un ou plusieurs pseudonymes). La règle actuellement en vigueur oblige le catalogueur à déterminer si l'un de ces noms est employé d'une manière prédominante et, le cas échéant, à retenir ce nom-là pour toutes les oeuvres de l'auteur en question, indépendamment du nom utilisé dans chacune. La modification envisagée nous amènerait plûtot à prendre la vedette d'un ouvrage au nom figurant dans celui-ci.

Il y a autant de pour que de contre dans ce projet de modification. C'est pourquoi le Comité canadien de catalogage juge nécessaire de consulter la collectivité des bibliothécaires du Canada avant de formuler sa position sur cette question.

The periodical is a most interesting document, full of Canadian and international snippets of information, not to mention advertisements and seven pages of music. We should be pleased to know about the existence of any other issues.

MLA CHAPTER MEETING

The New York State/Ontario chapter of the MLA met at SUNY Buffalo on Saturday Oct.

19. Panelists Curt Steinzor, SUNY Buffalo Library, Joan Swanekamp, Sibley Music Library, and Michael Wright, ethnomusicologist at the State University College at Buffalo, discussed "alternative" treatment of "music of the whole earth" in music libraries. Prof. James McKinnon, SUNY Buffalo, offered a cautionary perspective on the contextual nature of iconographical evidence. The chapter

members elected a new chair, Isabel Rose of Metro Toronto Library, and Secretary/ Treasurer Elizabeth Gamble, Cornell University.

CD's AT METRO

This past fall, the Music Department at the Metropolitan Toronto Library added compact discs to its collection. The discs, as with our record collection, do not circulate; we provide 30 listening stations in our department for the patrons to use.

In selecting our players, we searched for a machine that was well reviewed in the major magazines as well as meeting our requirements. First, we needed a machine that provided its own output capabilities through headphones; our amplification system was too limited and outdated to handle the dynamic range of the CD. To minimize staff time training patrons, the controls had to be few, well marked, and operation of the machine had to be straightforward. We also needed a machine with indexing capabilities (most important for operas and larger works.

The machine we chose was the Yamana CD-X2. Not only was it well received in audio circles, but it met our requirements at a price we could afford! The machine also rejects improperly inserted discs. If you are selecting a machine, test it to see what it does when a disc is not completely inserted in the drawer, as many patrons are apt to do.

Each patron gets a brief "run-down" on basic operation, there are directions for operation at each station, and staff are available for further assistance. At present, we have two machines, with more planned for the future. Security is still a concern, especially because of the size of the disc. We have tried to dissuade thieves by inscribing the accession number on the disc, inside the centre hub, along with the Library's initials. Security labels are placed inside the plastic cover, as well as in the librettos and inserts.

The plastic covers for the discs are not

wearing well. Ours are already breaking and are cracked in several places. If any other libraries are facing this same problem, we would like to hear how you are handling it. Despite this minor problem, both the staff and the patrons have had no difficulties with the machines, and all seem glad that we have the discs available for use.


